8. No DHCP servers allowed, as there is one present at the event. Make sure you don't inadvertently have one running on your machine (especially Win2K machines).
9. No Display/transferring of Pornography.
10. No transferring of illegal software across the networks.
11. No hacking or intentional network disruption.
12. No fighting. Maintain orderly conduct.
